Remarks: Participants should bring their own rackets for the course, while shuttlecock will be provided. The course will be conducted in Cantonese.

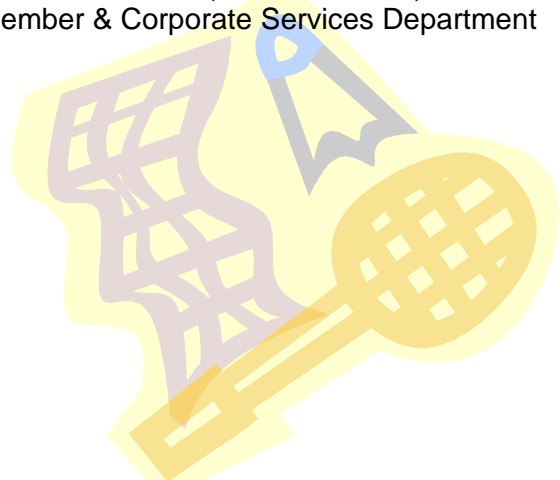
