The **Bowling Interest Group (BoIG)** cordially invites you to join its "Winter League" which will last 12 weeks up to end of March 2012. Form your own team or join as a member of a team and meet some new teammates.

Details are as follows:

- Dates:** 25 November 2011 to 9 March 2012 (all Fridays)
25 November; 2, 9 & 16 December; 6 & 13 January;
3, 10, 17 & 24 February; 2 & 9 March 2012
- Time:** 7:30 pm – 9:30 pm (All matches start at 7:30 pm sharp.)
- Venue:** South China Athletic Association Bowling Centre (SCAA)
- Assembly time and place:** 7:00 pm at Section A area of SCAA for the first session of the league
- Fee:**
- \$1,450 per player for the whole season (i.e. \$121 per session)
 - no pro rata payment is accepted.
 - \$8 for shoes rental per session.
- Capacity:** Min 8 teams (max 10)
- Format:**
- Each team will comprise 3 players, out of which at least 2 team members must be HKICPA members.
 - A maximum of 3 reserves is allowed for each team with no restrictions as to whether they are HKICPA members or not.
 - At least 1 team member must be HKICPA member in the league game.
 - A total of 12 sessions will be held in the league season which includes the first 9 rounds of play-off; 3 games each with handicap and the last 3 rounds for positioning.
 - Detailed league rules will be distributed to registered players.
- (* To comply with the lane booking requirement, at least one member of each team needs to be a current member of SCAA. If none, one of the teammates has to join SCAA membership, whose annual fee is HK\$100 for ordinary member.)*
- Prizes:**
- Team Champion, 1st Runner-Up and 2nd Runner-up.
 - Trophies for individual men and ladies high series (i.e. Highest Week's Average).
 - Trophies for most improved players.
