8:15 am	- Assemble in front of Jiming Golf Services Co. (吉明高爾夫公司) next to the cafeteria (turn right after exiting from the Chinese immigration building at Huanggang, Shenzhen 深圳黃崗口岸)
8:30 am	- Shuttle bus departs for FHSGC
9:15 am	- Arrive at the FHSGC
9:40 am	- Tee off (1st flight)
3:30 pm	- Shuttle bus leaves FHSGC for Huanggang
4:15 pm	- Arrive at Huanggang, Shenzhen

No. of players: Minimum 4 and maximum 16

Fee: **RMB\$650 or HK\$800** per person **payable to Eddie Loong in cash on site.** This fee includes a round of 18 holes; use of locker, caddie and golf cart (on two-player-sharing basis, an extra charge of RMB\$100 if one person uses the golf cart alone); plus round trip shuttle bus service between Huanggang, Shenzhen and FHSGC. *Traveling expenses to Huanggang, catering charges and other expenses at the golf club will be at players' own accounts.*

Documents required: HKID card and valid Home Return Permit (回鄉証) / passport with visa to China
